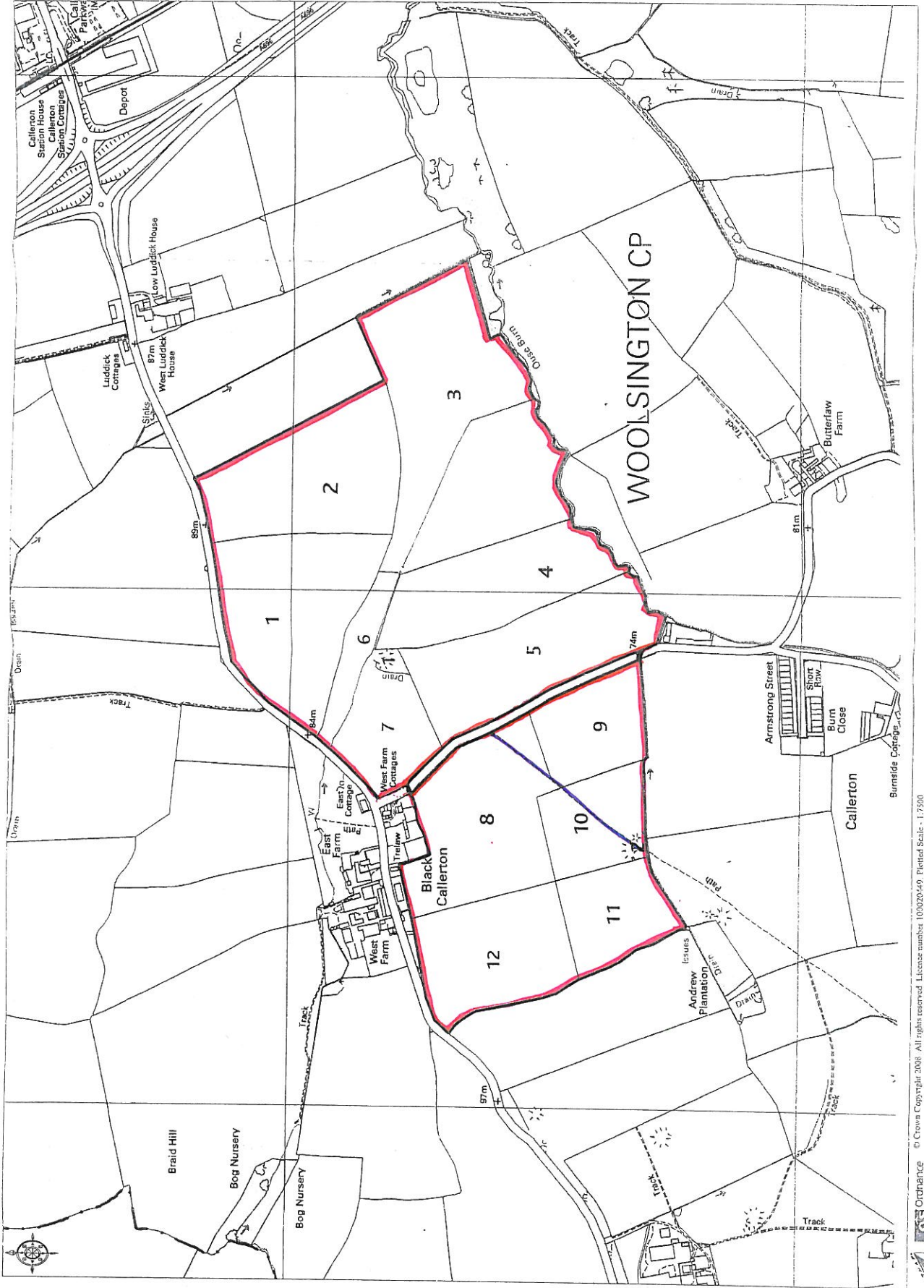

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

1. I am and have been since 1 November 2004 the company secretary of Bays Leap Dairy Farm Limited ("the Company")
2. Since 13 October 2000 the Company has been the owner of the land known as East Farm Black Callerton Newcastle Upon Tyne NE5 1NS more particularly delineated on the plan accompanying this declaration and thereon edged red.
3. On the 20th day of January 2009 the Company deposited with Newcastle City Council, being the appropriate Council, a statement accompanied by a plan delineating the Company's property by red edging which stated that the way coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as a footpath and no other ways had been dedicated as highways over the property of the Company.
4. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement deposited on 20th January 2009 referred to in 3. above and at the present time the Company has no intention of dedicating any more public rights of way over its property.
